

SUBJECT: State of Florida Purchasing Manual Revisions

The following rule revisions became effective July 6, 1998, and are now in the Purchasing Manual found in Purchasing Direct:

- 60A-1.001(7)- revises the reference to Section 120.57(3) F.S., to conform to statutory revision.
- 60A-1.001(8)(a)- revises the reference to Section 120.57(3) F.S., to conform to statutory revision and reference bids or proposals instead of bids-proposals for clarification
- 60A-1.001(9) - revises the formula for adjusting category thresholds
- 60A-1.002(6) - revises reference to Bid-Request for Proposal to read Bid and Request for Proposal for clarification, revises PUR form revision dates to read 6-1-98, revises the reference to Section 120.57(3) F.S., to conform to Statutory revision
- 60A-1.006- deletes Procurement protest points of entry in rule 60 A, these guidelines are now outlined in Chapter 28-110 Florida Administrative Code
- 60A-1.007 - revises title of Division of Purchasing Manual for Development of Specifications

- 60A-1.008- revises PUR form revision dates to read 6-1-98, adds service to the definition of a state negotiated agreement price schedule, adds requirement for agencies to report on purchases they approved as exception to state term contracts below the threshold for Category One
- 60A-1.009 -incorporates statute reference for definition of an emergency
- 60A-1.010- revises title and revision date of Form PUR 7006, revises reference to Florida Statutes
- 60A-1.015 - revises PUR form revision dates to read 6-1-98
- 60A-1.016 - revises PUR form revision dates to read 6-1-98,
- 60I - repealed, the council was abolished by the repeal of subsections (5) and (8) of Section 287.073, F.S., by Chapter 97-286, Law of Florida, Section 18.

Rule revisions for 60A, amend various State Purchasing rules which reference forms PUR 7006, 7027, 7028, 7031, 7033, 7050, 7051 and 7109 to conform to statutory revisions. These forms may be ordered through PRIDE of Florida.
